# 2. Call AAL-2015

This report presents statistics regarding submitted and ranked proposals in response to the second call under the Active and Assisted Living Programme entitled "LIVING ACTIVELY AND INDEPENDENTLY AT HOME: Support more older adults to live longer in their homes with the contribution of ICT based solutions"

The call deadline was on 28 May 2015 with an indicative total funding of 31,900,000 € that was committed by 20 national funding authorities from 17 AAL Partner States and the European Commission.

A total of 66 proposals are eligible for the evaluation in this call and 43 of them constitute the ranking list, i.e. these were positively evaluated by independent experts. Funding budgets under the AAL Programme are reserved for organisations residing in the country that committed the funding, and thus, the outcome of the evaluation process does – very likely – not match the available national budgets in an optimal way.

On the basis of the ranking list a budget optimisation process is conducted that reflects the availability or scarcity of national funding budgets. This process will lead to changes in the composition of the consortia of ranked proposals. At the end of this process, a funding list is compiled which is the list of proposals with whom the negotiations will be started if the AAL General Assembly approves the list.



Chart 1: Partners in submitted proposals









Chart 2: Coordinators in submitted proposals

Chart 3: Total cost and total requested funding for submitted proposals








Chart 4: Ratio of total requested funding over total project cost




Chart 5: Organisation types in submitted proposals





Chart 6: No. of organisations in ranked proposals per country

Chart 7: No. of coordinators in ranked proposals per country









Chart 8: Budget figures in ranked proposals per country in ranked proposals




Chart 10: Organisation types in ranked proposals
