- Private companies established in the Brussels Capital Region with a sustainable activity in this region based upon a sound business model.
- Brussels Capital Region based universities,
- Research organisations
- Associations of end users

**Associations** will be funded following the analysis of their structural activities (economic/not-economic activities).

- Associations without economic activity- 100% of funding
- Associations with max 20 % or less than 20% of economic activities- 100 % of funding
- Others association with more than 20% of economic activities- funded on the same rules as private companies
- Calculation of dedicated funding for associations will be based on their statutes, financial accounts

The associations need to prepare and submit the document “qualification of beneficiary”.

**Additionally to the general criteria developed by the AAL program**, Innoviris funded projects will fulfil some general regional eligibility criteria:

- Regional beneficiary develops entirely or partially its activities in Brussels Capital Region
- Regional beneficiary will perform a research or demonstration activity in the project
- The project will be innovative and will present the positive impact on regional economy and employment by valorisation of results in the region
- Regional Beneficiary has not received public funding for the same activities
- Regional Beneficiary has fulfilled the obligations in the context of previous grants allocated by the Region
- Regional Beneficiary can guarantee its own financial contribution to the project if this isn't granted at 100%

All applicants should demonstrate their viability and financial soundness regarding their own contribution to the project and the implementation of the results.
